



Calor provides this information on the basis that all work has been suitably planned to ensure adequate information is available to the Project Supervisor Construction Stage / person in charge on site to allow work to proceed safely in compliance with relevant legislation.

CONSTRUCTION SITE - SAFETY INFORMATION

1. Before digging or operating excavation equipment in the immediate vicinity of LPG storage vessels or gas mains contact Calor Customer Engineering Department by email on dialbeforeyoudig@calorgas.ie or call our “dial before you dig” number on 01-2916135.
2. Calor operates a Dial Before You Dig service to enable those involved in excavations to obtain LP Gas network maps prior to starting work.
3. Only Calor authorised personnel are permitted to carry out - PE Mains & Services Installation.
4. Only RGII Registered Installers are permitted to carry out gas works.
5. Unrestricted access to LPG vessels, isolating valves and meter installations must be maintained.
6. No electrical equipment ie. transformers permitted within 1 metre of gas mains.
7. Site personnel must know how/where to turn off the gas supply in the event of an emergency.



EMERGENCY ACTION

- In the event of damage to “Gas Mains or to LPG Storage Vessels” Stop all work immediately and contact Calor Emergency No 01 2916229.
- If you are unable to turn off the gas supply contact Calor and you should also contact the Emergency Services.
- Shut down all plant and machinery operating in the immediate area of the damage.
- Turn off the “Emergency Shut Off Valves” located inside the valve chamber on underground vessels and under the hood on above ground vessels.
- **Do not** operate electrical switches and equipment or mobile telephones near the affected area.
- **Do not** start or attempt to move trucks or motor vehicles or other machinery.
- Clear all personnel from the affected area and take measures to restrict unauthorised entry.
- Keep control of the affected area and keep cordoned off until Calor emergency response crew arrives and takes control of the incident.
- **Do not** attempt to repair the damage or take remedial action without first getting authorisation and clearance from Calor Gas or the Emergency Services.
- **Do not** recommence work or allow personnel into the effected area until a safety clearance is received from Calor Gas or the Emergency Services.
- It is important to report to Calor all damage/incidents even if there is no smell of gas or evidence of a gas escape.

Maps will be sent out by post or by email where appropriate. When you contact Calor to request a map, ensure you give the precise location of the intended works. You may be required to give some information regarding the nature of the planned work, i.e start date, any high risk activity, etc.

Ensure you have allowed enough time for the maps to be obtained.

Don't put yourself at risk from damaging underground LPG Tanks or gas services, trial hole and dial before you dig.

95% of all damages to gas pipes are caused by mechanical excavators.
